Two Paws Up Grooming Release

**This Release applies to all grooming appointments at Two Paws Up
for one year from the date at the bottom of this release.**

I _____, hereby waive and release **Two Paws Up**, its employees, owners and agents from all liability for injury or damage which I or my dog may suffer as a result of the pet grooming process.

I have disclosed any and all known dangers associated with my pet, including behavioral issues that may impact the safety of the grooming staff as well as the safety of my pet at **Two Paws Up**.

For Emergencies: I hereby grant permission to **Two Paws Up** to obtain emergency veterinary treatment for my pet, at my expense. For my pet's benefit, Two Paws Up will use the services of the nearest veterinarian.

Medical Problems: I understand pet grooming can expose a hidden medical problem or aggravate a current one. This can occur during or after grooming.

Senior Pet Grooming: I understand senior pets have an increased risk of injury and/or stress while grooming.

Tranquilization: **Two Paws Up** will not tranquilize a pet for grooming nor will we accept a pet who exhibits signs of having been tranquilized.

Vaccinations: All pets are required to show proof of current rabies vaccination prior to grooming.

Fleas & Ticks: If we find your pet is found to be infested with fleas or ticks, **Two Paws Up** will treat your pet as we deem necessary. **Two Paws Up** will not be held responsible for any side effects which may occur. I also understand that any such treatments are not guaranteed 100% effective.

I certify that my unspayed female brought for grooming is at least two weeks out of her most recent heat.

Dematting: **Two Paws Up** will exercise all necessary precautions during the grooming process, but I am aware that if my pet is matted, it may be necessary to shave or dematt my pet, and that these procedures may have unpleasant consequences such as clipper burn, brush burn, or nicks and cuts. **Two Paws Up** will use all precautions during these procedures but will not be held responsible for the aforementioned side effects. **(See Two Paws Up Shave Down Contract.)**

I agree that any dispute arising under this contract or any interpretation required of or the enforcement of rights and duties under this contract shall be subject to final and binding arbitration pursuant to the American Arbitration Association ("AAA"). The award of the arbitrator (s) shall be enforceable according to the applicable provisions of the California code of Civil Procedure. The arbitrator (s) may award damages and/or permanent injunctive relief, but in on event shall the arbitrator (s) have the authority to award punitive or exemplary damages.

Two Paws Up Shave Down Release
(required for all dogs shaved to 1/2" or shorter - #7 blade or more)

This Release applies to this specific grooming appointment at Two Paws Up.

I understand and agree that this release is a supplement to the **Two Paws Up** Grooming Release previously signed.

I understand that **Two Paws Up** does NOT recommend shave downs except when medically necessary or when the pet is so severely matted that in our professional opinion the matts cannot be combed or brushed out without causing the pet unnecessary discomfort and distress.

I am aware that the shave down process makes use of electric clippers that may leave the pet's coat no longer than 1/16", and authorizes us to "shave down" the pet.

I am aware that after being shaved down, my pet may require sunscreen in order to prevent sunburn.

I am aware that these procedures may have unpleasant consequences such as clipper burn, brush burn, nicks or cuts. **Two Paws Up** will use all precautions during these procedures but will not be held responsible for the aforementioned side effects.
